

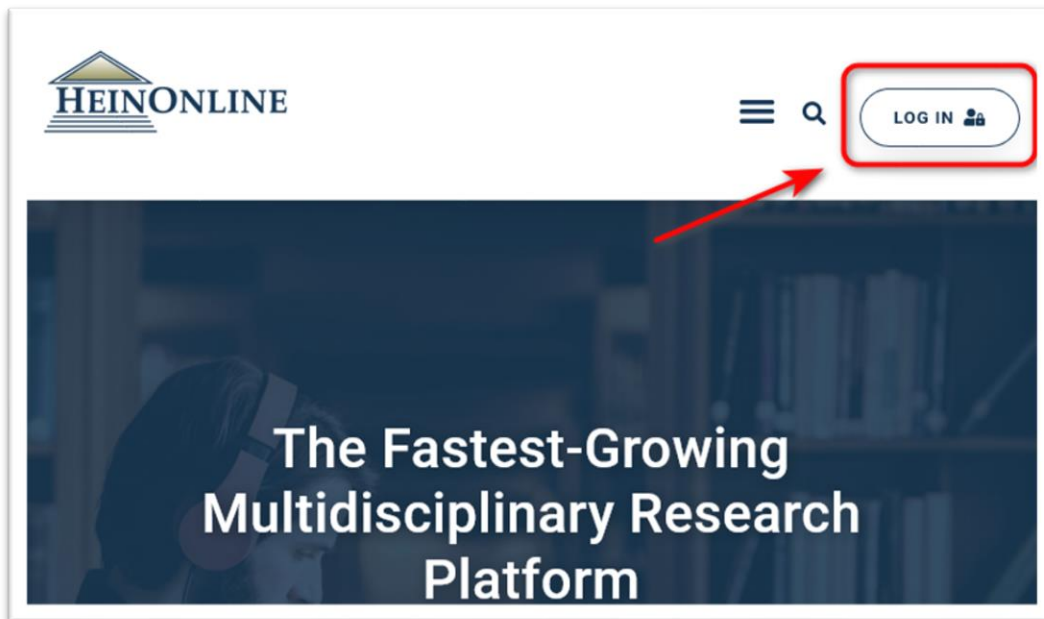

## INSTRUKCJA DOSTĘPU

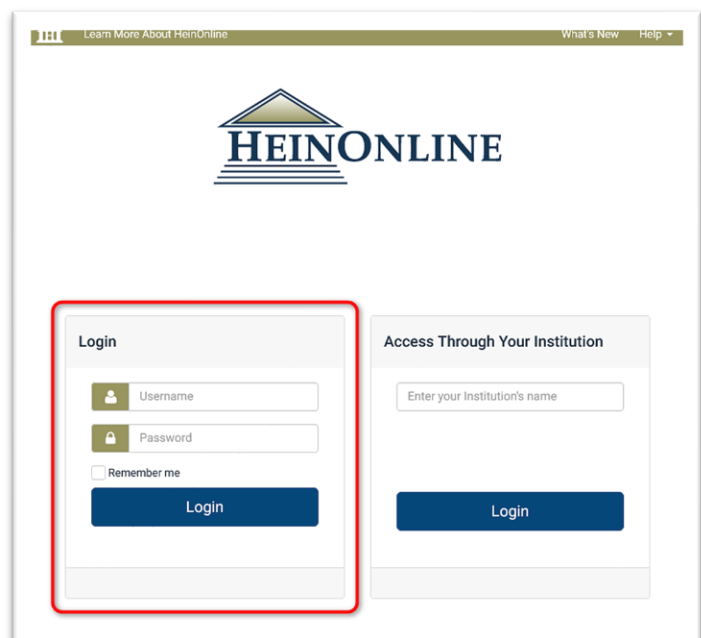
Dostęp do bazy HeinOnline zarówno zdalnie, jak i z sieci UKSW **odbywa się poprzez stronę wydawcy** (z pominięciem serwisu Pulpit UKSW).

Aby skorzystać z zasobów bazy HeinOnline należy:

1. Wejść na stronę <https://home.heinonline.org>.
2. W prawym górnym rogu strony kliknąć przycisk **LOG IN**.



3. Wpisać dane logowania otrzymane przez formularz kontaktowy; **login** (username) i **hasło** (password), a następnie kliknąć przycisk **Login** lub klawisz **Enter**.



4. Po poprawnym zalogowaniu ukáže się widok, obejmujący wszystkie kategorie tematyczne na platformie HeinOnline.
